## **SASHA PULSE SHOWER SYSTEM**

### **1 (ONE) YEAR LIMITED WARRANTY**

#### **1. Defects Covered: Warranty Period**

Mega Supply Store LLC ("Mega Supply Pro") warrants to the original consumer purchaser who purchases this Shower System (the "Product") for use in his or her own home, that the Product will be free from defects in material and manufacturing workmanship for a period of 1 (one) year from the time of delivery. For all other purchasers (including, but not limited to purchasers for industrial, commercial and business use), the above warranty will apply for a period of 1 (one) years from the original date of purchase.

#### **2. Remedy**

If the Product does not conform to the above warranty, Mega Supply Pro, at its option, will repair or replace the Product, free of charge, or refund your purchase price. For warranty claims, please send an email with the claim details to [info@megasupplypro.com](mailto:info@megasupplypro.com). Mega Supply Pro may require that you return the Product to Mega Supply Pro, shipping prepaid, in which case Mega Supply Pro will provide you with a return materials authorization number (RMA). Mega Supply Pro may also require that you provide evidence of the date you purchased the Product. Mega Supply Pro will ship a new or repaired Product to you, at the expense of Mega Supply Pro, or refund your purchase price. Service labor performed by you or others in connection with the removal or replacement of the Product will not be reimbursed by Mega Supply Pro.

#### **3. Exclusions**

Mega Supply Pro shall not be responsible for the Product's failure, and the above warranties will not apply if the Product fails due to improper installation, improper use, modifications, or repairs by anyone other than Mega Supply Pro, or accident or abuse (including damage during shipment).

#### **4. Warranty on Repairs and Replacements**

For consumer purchasers who purchased the Product for home use, repaired or replacement Products will continue to be covered under this warranty for a period of 1 (one) year from the date of replacement's delivery. For other purchasers, repaired or replacement Products will be covered for the balance of the original warranty period.

#### **5. No Other Warranties: Limitation of Liability**

Other than the 1 (one) year limited warranty stated above, Mega Supply Pro disclaims all other warranties, express or implied, including but not limited to warranties of merchantability and fitness for a particular purpose, to the extent permitted by applicable law. The remedies stated above are your sole remedies in connection with this warranty. In no event will Mega Supply Pro be liable to you for any damages, whether direct, indirect, incidental, special or consequential, including but not limited to lost profits or business interruption, arising out of or relating to the Product or its use, whether under a contract, warranty, tort, or any other cause of action, even if Mega Supply Pro has been advised of the possibility of such damages. Notwithstanding the term of any limited or implied warranty, or in the event that any limited warranty fails of its essential purpose, in no event will Mega Supply Pro's entire liability exceed the purchase price of the product. Some states and provinces do not allow the exclusion or limitation of incidental or consequential damages so the above limitations or exclusions may not apply to you. This limited warranty gives you specific legal rights, and you may also have other rights which vary from state to state and municipality to municipality.
